- INTRODUCTIONS: Everyone went around the room and introduced themselves.
- IV. MINUTES: Megan Clere had one edit to the December 2018 Minutes a motion was missing from discussion of Megan Clere's review. Debra Waller motioned to offer a 10% raise starting December 26th, 2018. Rebecca Ortwein seconded. Mike Wilson motioned for the approval of the December 2018 Minutes with the edit. Victor Vanover seconded. All in favor.
- W. TREASURER'S REPORT: The December 2018 Treasurer's Report and Financial Reports were presented. Debra Waller motioned to accept the December 2018 Treasurer's Report. Mike Wilson seconded. All in favor.

VI. DISTRICT REPORTS:

- a. District of Conservation (DOC) Report: Megan Clere briefly read through the January 2019 Reminders from DOC. Pam Williams is no longer BCCDKY's Field Rep, and Jim Roe will be taking her place. Megan Clere read Pam Williams' letter to the District.
 - i. 10-Minute Training: Rebecca Ortwein reviewed the 10-Minute Training for committees.
- b. Ian Young, NRCS: There was no report from NRCS.
- c. District Staff Reports
 - i. Susan Brown: There were two educational grants submitted: one from Kelly Elementary and the other from Union Point Academy (UPA). Kelly Elementary is requesting \$684.64 for their habitat-certified school BCCDKY's portion is only 19% of the total request. The additional 81% has already been funded via other sources. UPA is requesting \$1,000 for their "Sow Life Lab" to create an outdoor classroom. In the budget, there is only \$1,397.69 left. Discussion was opened for the group. UPA has a large portion of their budget that can be borrowed or purchased for cheaper elsewhere Susan Brown and Mark Jacobs will get with them to reevaluate their budget and reapply. Debra motioned to offer Kelly Elementary an educational grant *up to* \$684.64 with additional advice given. Mike Wilson seconded. All in favor.
 - ii. Mark Jacobs: Mark Jacobs presented potential projects for the Amazon Mitigation.
 - iii. Megan Clere: The Forest Conservation Workshop is coming up and has around 20 registrants so far. BCCDKY Staff has also been working with NKU's ENV Seminar class for two projects: wildlife monitoring and conservation teen camp. This process began last week and will continue over the next few months.
- d. J.T. McMullen, NWOI Pilot Project: J.T. McMullen has around 160 hours left with BCCDKY.
- e. Kevin Black Conservation Intern: Kevin Black is working on his Independent Study project at the YMCA Camp Ernst Wetland. He is studying the avian diversity and has collected around 10-12 hours of data with around two dozen different species. Kevin Black is working with Jack Phillips from Boone County GIS to create an accurate wetland map of Boone County to pair wih his study.
