Jeff Thomas made a motion to approve the request utilizing services of the Boone County Public Works sign shop with an addition of a sign to be used by the road to provide better directions to the Center. Shannon Galbraith-Kent, Ph.D. seconded the motion. All were in favor, motion passed.
